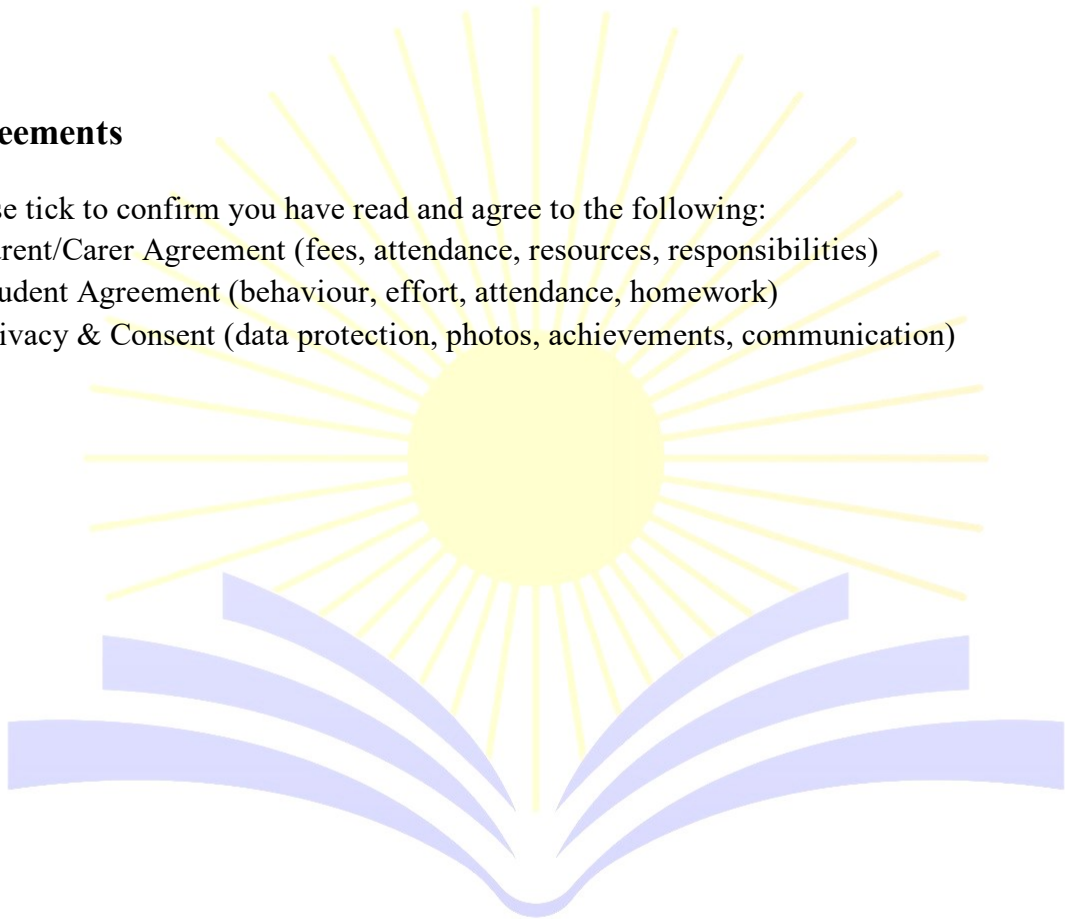

MIVIA Learning – Parent/Carer Agreement

By enrolling my child in MIVIA Learning lessons, I (parent/carers) agree to the following terms and conditions:

1. Fees & Payments

- I am responsible, and Fees are payable four to five weeks before lessons commence every month in advance
- All fees are fixed, non-refundable, and non-transferable.

2. Absences & Attendance

- I must inform MIVIA Learning at least 24 hours in advance if my child will be absent. I accept responsibility for my child's absence.
- If my child is absent for three consecutive weeks, their place may be given to another student.
- If the child is absent without the 24-hour notification, fees remain payable for all lessons, including those missed, as resources and support will be provided to help my child catch up.

3. Learning Environment & Resources

- I will provide my child with a suitable device, required resources, and a quiet environment during lessons and for homework
- I will ensure my child attends lessons punctually, whether face-to-face or online.

4. Classwork & Homework

- I am responsible for ensuring classwork is sent to the teacher during lessons for feedback.
- I will supervise my child during lessons to ensure focus, except for students in Years 8–11.
- Failure to complete homework for three consecutive weeks may result in my child's place being given to another student.
- I understand that my child must make a genuine effort to complete classwork and homework punctually to make progress.

5. Teacher & Parent Roles

- I will support communication between my child and the teacher outside of lesson times.
- I will assist with marking classwork and homework where necessary to help identify areas of weakness for younger students
- I understand that the teacher's camera may occasionally be turned off during lessons for focused observation or assessment purposes.

6. Commitment

- I understand that both I and my child must comply with the above rules and expectations to ensure effective learning and progress.
